Membership renewal occurs on a calendar year basis. Please remit payment upon receipt.

Active: This classification is open to all public employees and elected or appointed officials having responsibility for, or engaged in, the function of governmental finance in any public jurisdiction of the State of Arizona. **\$60/yr**.

Commercial: This classification is open to all persons not currently employed by a governmental agency whose livelihood is derived primarily from commercial or professional activities related to municipal finance. **\$110/yr**.

Associate: This classification is open to any person not eligible for active or commercial membership but who is interested in the principles and practices of governmental finance. **\$35/yr**.

Student: This classification shall be open to any student who is currently attending an accredited undergraduate or graduate program on a full-time basis for the purpose of entering the profession of public finance and is not qualified for Active Membership. **\$15/yr**.
